Dear Artists:

**\* New Information for 2019\* Make sure you read thoroughly as there is new information regarding this year's art fair.**

The residents of Northfield Hills cordially invite you to apply for the 45<sup>th</sup> annual Art-on-the-Lake.

Northfield Hills is located in Troy, Michigan on Long Lake Road between Crooks and Coolidge, minutes away from Birmingham, Bloomfield Hills and Rochester. Northfield Hills is the largest and best-known condominium development in Troy, surrounded by 1000's of exclusive single family homes. Publicity and our location, with its 10-acre Lakeshore setting, combine to attract a stream of discriminate, appreciative people.

The show will be held on Sunday, August 25, 2019 beginning at 10:00 a.m. until 6:00 p.m. rain or shine. Complimentary coffee and muffins will be served during set-up. All booth locations have been planned according to media mix. Many of our booths have parking available behind them but this is on a first come first serve basis, so apply early.

Each display area will be 12' x 12' and located on grass. Artists are responsible for providing their own display equipment and weather protection. **For your convenience, we are one of the only shows that allow you to park one (1) vehicle behind your booth.**

\$80.00 along with 4 slides/pictures (3 slides of work & 1 slide of your fully stocked outdoor booth) identified with your name is due **no later than June 3, 2019**. After June 3<sup>rd</sup> there will be a \$10.00 late fee. Slide/photo jurying is done separately for each category. The jury panel consists of professional artists. Jurying is anonymous and silent. Descriptions of process provided by the artists on the applications will be read. Each applicant is assigned a number; no names are used. Four slides/photos from each artist are viewed simultaneously. **Since selection to the art show is based on these slides/photos, they should accurately represent the work to be exhibited. Jurors will be looking for originality, technique, design and overall impact. Just because you were in the show in the past does not automatically get you a spot in this year's show. So, ALL artists must provide photos/slides.**

**Only artists accepted in the jewelry category may display and sell jewelry. Only work consistent with the accepted juried slides may be exhibited and sold at the art show. Nothing of lesser quality or completely different style than that which is clearly visible on slides may be exhibited. Art on the Lake reserves the right to remove work from the show that is in violation of the above rule.**

Artists are expected to exhibit their work themselves. The following is not acceptable:

Manufactured or Kit Jewelry  
Products cast from commercial molds  
Eggshell or seashell crafts  
Commercially made products including fiber/wearables

Promotional mailers are available. **YOU MUST send a 6 x 9 self-addressed, \$2.00 stamped envelope and we will mail them and your jury results in ample time for advertising. Slides/photos will be returned the day of the art show.**
